#### **Efficiency Rate in Customs Clearance**

Import Efficiency rate – The rate takes into account Import declarations cleared in less than 24 hours over the total of Import declarations cleared.

- ✓ Customs and Tax Legislation









#### Export - Percentage of document and physical inspections





#### New Export Procedure - Single Export Declaration (DU-E)






#### **Register and Control of Export Operation**


