Em 05/12/2024 o aviso do chamamento público foi publicado nos sites <http://portaldecompras.sistemaindustria.com.br> e <http://www.portaldaindustria.com.br/licitacoes> e [Correio Braziliense](#), garantidos os requisitos da transparência, equidade, ética e integridade. A sessão de abertura foi agendada para o dia 16/12/2024. No entanto, após a abertura do chamamento público as empresas participantes excederam significativamente o valor estimado. Em tentativas de negociação, as empresas comunicaram que uma diminuição dos valores não seria viável. Diante disso, o processo foi declarado fracassado.
