# Confidence Has Decreased Across All Company Sizes, Regions, and the Majority of Sectors

In September 2023, confidence levels dropped in all industry sizes (small, medium, and large), across all regions of Brazil, and in 21 out of 29 sectors. Consequently, five sectors within the industry have shifted from confidence to a lack thereof.



In September, confidence declined in 21 out of the 29 industry sectors while increasing in eight. As a result, five sectors have transitioned from confidence to a state of lack of confidence: Metal products, Specialized services for the construction, Motor vehicles, Plastic products, and Furniture.

Thus, in September, 19 out of 29 industry sectors exhibited confidence, while 10 sectors recorded a lack of confidence.

#### ICEI by company size

Confidence dropped in all sizes of industry in September, with the biggest drop in small-sized companies (-2.3 points), followed by medium-sized companies (-1.8 points) and large-sized companies (-1.5 points).

As a result, the Small Business Confidence Index decreased from 52.2 points to 49.9 points, crossing the 50-point dividing line. While it's close to this threshold, this outcome signifies a shift from confidence to a lack thereof. Medium and large-sized companies continue to maintain their confidence levels, notwithstanding the dip in confidence observed in September.

Industrial confidence saw a decline in all regions of Brazil in September. The most significant declines were observed in the Midwest (-2.9 points), North (-2.5 points), and Northeast (-2.2 points). Meanwhile, the Southeast and South experienced more moderate decreases, with -1.3 points and -1.2 points, respectively.

Despite the overall drop in confidence, all regions, except for the South, continue to maintain their confidence levels.
